**ISSUE**

Should the Board approve the participation in the State of Illinois purchasing program for the 2022-2023 bulk road salt purchase.

**DISCUSSION**

The State of Illinois Bureau of Strategic Sourcing & Procurement is planning to award the bid for bulk road salt in the June / July 2022 time frame. Staff is requesting Board approval to participate in this year's program.

Last year's salt price thru the State's program was \$60.79 per ton for salt, the price for salt outside the State's program averaged \$68.52 to \$140.00 per ton last season. Although staff is not certain on the salt price for this season historically it has been beneficial to join the state program.

Based on past history of usage, current end of season estimates for remaining salt and the usage for this current season, Staff estimates the need for approximately 2,000 tons of salt to execute the 2022-2023 snow and ice control program.

**COST**

The estimated cost for 2,000 tons of salt at \$60.79 per ton is \$121,580.00. The funds have been included in account number 30-53-6615: Snow and Ice Control Supplies for the FYE 23 budget.

**RECOMMENDATION**

The Village Board approves **Resolution #20220503PW2** authorizing an agreement for the purchase of bulk road salt for snow and ice control operations through the State of Illinois, Bureau of Strategic Sourcing & Procurement.
