ISSUE

Should the Village Board approve a resolution for the purchase of street light poles.

DISCUSSION

FYE 2023 Budget included funds to purchase 4 Standard Street Light Poles and 2 Decorative Street Light Poles. There are 2 street light poles that need replacement within the Village and the remainder will be held in stock for emergency replacements. The current estimated delivery for street light poles is 3-4 months. Staff received 2 proposals for the street light poles and freight.
