ISSUE

Should the Village approve an ordinance amending the Village Code Sections 3-2-1 Definitions and 3-2-6 License Classifications to establish a New Class S Liquor License – Event Venue.

DISCUSSION

At the August 17, 2021 Village Board meeting, the Board approved an annexation agreement and special use permit for the Rosewood Farm event venue at 41W738 Prairie Street. Rosewood Farm is a flower and vegetable farm that also host events and classes for the general public. Rosewood Farm reached out to staff regarding a liquor license for service of alcohol at their events and also for sale in their farm shop. As the Village does not currently have a license classification that meets the sales intended, staff worked with Rosewood representatives to develop an appropriate license classification.

The Class S (Event Venue) liquor license classification as presented provides for 1) the sale of liquor to be consumed on premises, 2) the sale of alcohol to be consumed off premises and 3) the consumption of alcohol brought to the venue by a patron provided the alcohol is served by an appropriately trained venue employee.

Approving the liquor license and setting the fee will be addressed through a separate resolution as will the approval of the liquor license. Staff is proposing a license fee of \$750.00 for the Class S classification.

COST

There are small costs to codify the ordinance.

RECOMMENDATION

That the Village Board approve an ordinance amending the Village Code Sections 3-2-1 Definitions and 3-2-6 License Classifications to establish a New Class S Liquor License – Event Venue.

An Ordinance Amending Village Code Section 3-2-1 (Definitions) and Section 3-2-6 (Liquor License Classifications) Establishing a New Class S Liquor License – Event Venue

BE IT ORDAINED by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows;

WHEREAS, the Village of Sugar Grove is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and accordingly, acts pursuant to the powers granted to it under 65 ILCS 5/1-1 et seq.; and,

WHEREAS, the Illinois Liquor Control Act, 235 ILCS 5/4-1, establishes that the Village of Sugar Grove Board of Trustees shall have the power by general ordinance or resolution to determine the number, kind, and classification of licenses, for sale at retail of alcoholic liquor; and,

WHEREAS, a request has been made to the Village to establish a new “Class S – Event Venue” liquor license; and,

WHEREAS, the Village of Sugar Grove Board of Trustees finds that it is in the best interests of the citizens of the Village of Sugar Grove to amend the Village of Sugar Grove Village Code Section 3-2-1 and Section 3-2-6-A with regard to the aforementioned proposition.

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:

SECTION ONE: TEXT AMENDMENTS

Section 3-2-1 (Definitions) of the Village Code shall be amended to add the following definition:

EVENT VENUE – Any indoor and/or outdoor location that is kept, used, maintained, advertised and held out to the public to be a place where events, activities and/or classes are held.

Section 3-2-6 (License Classifications) of the Village Code shall be amended to add a new Section 3-2-6-A-19 establishing a “Class S – Event Venue” liquor license and shall read as follows:

3-2-6-A-19. Class S – Event Venue

A Class S license authorizes

- a. The retail sale of alcoholic liquor to be consumed on the premises where sold,
- b. The sale of alcoholic liquor in its original package for consumption off of the premises where sold, and/or
- c. The consumption of alcoholic liquor carried into the venue by a patron to be consumed on the premises.

All alcoholic liquor consumed on the premises shall be served by a venue employee as

provided in 3-2-14 and 3-2-15.

SECTION TWO: GENERAL PROVISIONS

REPEALER: All ordinances or portions thereof in conflict with this Ordinance are hereby repealed.

SEVERABILITY: Should any portion of this Ordinance be declared invalid by a court of competent jurisdiction; the remaining provisions will remain in full force and effect the same as if the invalid provision had not been a part of this Ordinance.

EFFECTIVE DATE: This Ordinance shall be in full force and effect after its approval, passage, and publication in pamphlet form as provided by law.
