ISSUE

Should the Board adopt a resolution Amending Fees and the Number of Licenses per Liquor Class for Fiscal Year 2022-2023.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, from time to time the Village Board may set fees and the number of licenses for each liquor class. At the February 1, 2022 Village Board meeting, the Board approved the number of licenses and set the fees for the 2022-2023 year. Should the Board approve the addition of the Class S – Event Venue liquor license classification, the Board will need to update the number to reflect that Rosewood Farm has a Class S license and set the fee. Staff proposes a fee of \$750.00 for the Class S classification for FY 2022-23. The FY 2022-23 Initiatives include a review of all liquor license fees, which may result in a different fee recommendation effective FY 2023-24.

COST

The new Class S liquor license fee will result in an additional \$750 in revenue for Fiscal Year 2022-2023.

Amending Fees and the Number of Licenses per Liquor Class for the 2022-2023 Licensing Year

BE IT RESOLVED, by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois as follows:

WHEREAS, Village Code Chapter 2, Section 3-2-7: Number of Licenses, provides that the cost and fees for obtaining and maintaining liquor licenses within the Village of Sugar Grove shall be set from time to time by the Board of Trustees of the Village of Sugar Grove by resolution of said Board of Trustees; and;

WHEREAS, Village Code Chapter 2, Section 3-2-7: Number of Licenses provides that maximum number of allowable per Class Licenses shall be determined by resolution by the Board of Trustees. In addition, the Board of Trustees may regulate the number of licenses by geographical area within the Village of Sugar Grove;

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of the Village of sugar Grove, Kane County, Illinois as follows:

That the annual fee for each class of liquor license and the number of licenses per Class within the Village of Sugar Grove shall be allocated as follows:
