### ISSUE

Should the Village Board approve a resolution for the purchase and installation of IP Camera Systems for 9 Well Houses and 8 Lift Stations.

### DISCUSSION

FYE 2023 Budget included funds to purchase and install IP Camera Systems at 9 Well Houses and 8 Lift Stations. Staff worked with Correct Monitoring the company that installed and services the current Security and Access Control Systems to develop a project scope and systems. The equipment/systems selected would include 2 cameras at each location, lockable cabinets to house equipment, a monitor at each site for viewing or playback of cameras, 4 channel IP recorder and 2 TB hard drive and installation at each site.

Staff recommends waiving the competitive bid process to keep all of our security and access control systems uniform. Below is a breakdown of the costs for this project.

Installation and Equipment 9 Well Houses and 8 Lift Stations @ \$5,000 each <u>Total Cost</u> \$85,000

### COST

The cost of the Purchase and Installation of IP Camera Systems for 9 Wells Houses and 8 Lift stations is \$85,000.00. Account number 50-71-7003 Building Improvements has \$85,000.00 budgeted for the Purchase and Installation of IP Camera Systems at 9 Well Houses and 8 Lift Stations
