**ISSUE**

Should the Village Board approve the 2022 Pavement Marking Program.

**DISCUSSION**

The Kane County Division of Transportation offers a program similar to the State's Joint Purchasing Program in which Kane County Townships and Municipalities can take advantage of County pricing for pavement markings. The Village participated in this program last fiscal year, completing approximately 30,000 linear feet of marking. The 2022-2023 Fiscal Year Budget includes funds to continue participation in this program.

On Tuesday, May 10, 2022, the Kane County Division of Transportation opened sealed bids for the 2022 Paint Pavement Marking Program. The contract was awarded to the lowest responsive, responsible bidder, Preform Traffic Control Systems, Ltd., 625 Richard Lane, Elk Grove Village, Illinois 60007. Preform Traffic Control Systems, Ltd. has agreed to honor all awarded contract unit prices to local government agencies. Staff feels this program is the most cost effective and efficient means to fill this need.

The focus of the 2022 Program will be remarking Main St, Cross Street West of Rt 47, Waubensee Drive West of IL Rt 47, Granart Road Including the Roundabout, Bucktail Lane and Esker Drive Near the Middle School.

**COST**

The total cost of the 2022 Pavement Marking Program is \$15,000.00. The FYE 23 General Fund Streets Budget, account number 01-53-6405: Repair & Maintenance Services - ROW includes \$15,000.00 for this project.

## **RECOMMENDATION**

The Village Board approves Resolution **20220707PW1** authorizing the Director of Public Works to execute an agreement in the not to exceed amount of \$15,000.00 with Preform Traffic Control Systems, Ltd., 625 Richard Lane, Elk Grove Village, Illinois 60007 for the 2022 Pavement Marking Program.
