ISSUE

Should the Village approve an ordinance amending the Village Code Section 3-2-6 License Classifications - Class C – Temporary.

DISCUSSION

The Village of Sugar Grove has been approached by Catering by Michaels for a temporary license for the LIV Golf Event to be held at Rich Harvest Farms in September. Currently, the Village Liquor Control Ordinance does not provide a classification for forprofit organizations to apply for a temporary license. The new draft of the ordinance currently being discussed by the Board does provide for this, however, as the new ordinance will not be amended in time for Catering by Michaels to get all the paperwork they need in advance of the event, staff is proposing that the current ordinance be amended to remove the provision that temporary licenses can only be issued to local not for profit organizations.

COST

There are small costs to codify the ordinance, which are already included in the budget.

RECOMMENDATION

That the Village Board approve an ordinance amending the Village Code Section 3-2-6 License Classifications - Class C – Temporary.

VILLAGE OF SUGAR GROVE ORDINANCE NO. 20220707A

An Ordinance Amending Village Code Section 3-2-6-3 (Liquor License Classifications – Class C - Temporary)

BE IT ORDAINED by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows;

WHEREAS, the Village of Sugar Grove is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and accordingly, acts pursuant to the powers granted to it under 65 ILCS 5/1-1 et seq.; and,

WHEREAS, the Illinois Liquor Control Act, 235 ILCS 5/4-1, establishes that the Village of Sugar Grove Board of Trustees shall have the power by general ordinance or resolution to determine the number, kind, and classification of licenses, for sale at retail of alcoholic liquor; and,

WHEREAS, the Village of Sugar Grove Board of Trustees finds that it is in the best interests of the citizens of the Village of Sugar Grove to amend the Village of Sugar Grove Village Code Section 3-2-6-C with regard to temporary licenses.

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:

SECTION ONE: TEXT AMENDMENTS

Section 3-2-6-C (License Classifications - Temporary) of the Village Code shall be amended to read as follows:

3-2-6-C. Class C - Temporary

- a. A class C license authorizes the licensee to sell alcoholic liquor to be consumed on the premises where sold and not for resale in any form at a banquet, picnic, bazaar, fair, celebration, or similar private or public assembly and not containing more than six percent (6%) of alcohol by weight.
- b. Such temporary license shall be granted to local not for profit organizations legally chartered as such or governmental entities, for community events.
- c. Such license authorizes the retail sale and/or consumption of alcoholic beverages containing not more than six percent (6%) alcohol on municipally or other governmentally owned property. The boundaries of the licensed premises and the duration of the license shall be established by the local liquor commissioner. The licensee shall maintain the premises in a neat, orderly and safe condition, shall provide such traffic control and sanitation facilities to protect the public health, safety, welfare and morals of the residents of the village, and shall restore premises after expiration of the license to its prior condition, including the removal of trash, rubbish and garbage. No alcoholic liquor shall be brought onto the premises or consumed on the premises other than that provided by the licensee under the terms and conditions of this chapter.

- d. The license issued shall be limited to the premises specified in the license.
- e. Payment shall be made to the village for the actual costs incurred by the village in providing additional police personnel necessitated by improper conduct or control by the licensee on the specific premises. Each licensee who is to be held responsible for additional charges shall receive an itemized invoice therefor, shall be given an opportunity to review the charges with the liquor control commissioner, and shall thereafter promptly pay any such additional charge determined by the commissioner to be due the village.
- f. Such license shall be authorized on a day to day basis, but for not more than five (5) consecutive days.

SECTION TWO: GENERAL PROVISIONS

REPEALER: All ordinances or portions thereof in conflict with this Ordinance are hereby repealed.

SEVERABILITY: Should any portion of this Ordinance be declared invalid by a court of competent jurisdiction; the remaining provisions will remain in full force and effect the same as if the invalid provision had not been a part of this Ordinance.

EFFECTIVE DATE: This Ordinance shall be in full force and effect after its approval, passage, and publication in pamphlet form as provided by law.
