ISSUE

Should the Village of Sugar Grove Liquor Commissioner and Commission approve a Class B – Packaged Liquor and a Class Q – Tasting Permit liquor license for Shree Bhole, Inc D/B/A Village Liquors and Tobacco for the 2022-2023 licensing year.

DISCUSSION

Shree Bhole, Inc. reached out to the Village to acquire a new liquor license as they are purchasing Village Liquors and Tobacco effective this July. Shree Bhole, Inc. has completed the necessary fingerprinting and staff has found their application to be in substantial compliance with Village Code. Shree Bhole, Inc. will be charged a pro-rated Class B and Class S fee totaling \$1,208.33.

The licenses have been made conditional on the sale and transfer of the business. At this time, the Board does not have to approve a new resolution to amend fees and the number of licenses per liquor class as the number of licenses and name of the business will remain the same once ownership is transferred.

COST
