ISSUE

Should the Village Board approve a resolution to award the bid for the Police Fence Addition.

DISCUSSION

FYE 2022 Budget included funds to complete the Police Fence Addition. Staff developed specifications, solicited bids and on July 26, 2022 staff opened bids. Below is a breakdown of the bid received. Staff recommends awarding the Bid to Northern Illinois Fence based on excellent results on previous fence projects such as Well 7, 8, 9 and the Well 10 Water Treatment Plant completed for the Village by Northern Illinois Fence.

Northern Illinois Fence \$95,823.00

COST

The cost of the Police Fence Addition is \$95,823.00. The General Capital Projects 30-53-7003 Building Improvements has \$150,000.00 budgeted for the Police Fence Addition.
