#### **ISSUE**

Adam Hoover from NIMEC will make a presentation on a Community Solar Program.

#### **DISCUSSION**

In the past few years, there has been discussion at the Board level on the Village's solar panel regulations in the Village Code. As another option for residents who are interested in using solar energy for their residential home, there is a Community Solar Program. Adam Hoover, NIMEC, who handles the Village's electrical aggregation program is here to present the Community Solar Program. This is available to all residents and small businesses, and no solar panel installation is required. This program is backed by the State of Illinois to promote green energy.

There are two suppliers who currently offer the program, MC2 and Solstice. MC2 has been a supplier in the past for the Village's electrical aggregation program. MC2 is also currently sponsored by the Metropolitan Mayor's Caucus. Solstice is the other company who offers the program. With their program, the Village and Resident's each receive a \$100 credit for each resident who opts in to the program.

There is no obligation or contract for the Village with the Community Solar Program. NIMEC is looking for the Village Board to sponsor the program, for the confidence of Village residents to know this program is backed by the Village when mailings are sent out. All questions, concerns and issues are handled by NIMEC, not the Village.

#### **COST**

There is no cost to sponsoring the Community Solar Program.

#### **RECOMMENDATION**

That the Village Board discuss the presentation and the interest in sponsoring the Community Solar Program through one of the offering suppliers. A resolution would need to be approved for the sponsorship if MC2 was chosen.
