#### **ISSUE**

Shall the Village Board approve a Resolution approving an Agreement to amend the conditions of approval to a Final Plat of Subdivision (Kimme Subdivision).

#### **DISCUSSION**

After discussing this matter of changing the conditions of approval for the Kimme Subdivision plat at its August 16, 2022 meeting, the Village Board directed the Village Attorney to prepare a document to record against the land that obligates the property owner to pay the fee in-lieu-of construction of the sidewalk if the adjacent property to the west is subdivided within two years.

The Agreement is meant to run with the land so that it applies to the current and any future owner of the subject property. The Agreement is intended to memorialize the modification of the conditions of approval of the Final Subdivision Plat previously agreed to and approved by the Village Board.

The Agreement will be recorded against the property.

WHEREAS, the Corporate Authorities have determined that it is necessary and desirable to amend the conditions of approval to a final plat of subdivision heretofore recorded as Document No. 2021K045614, which Resolution included certain conditions of approval; and,

WHEREAS, as a condition of amending the conditions of approval to a final plat of subdivision the Corporate Authorities have caused preparation of an Agreement to Amend the Conditions of Approval to a Final Plat of Subdivision, attached hereto in **Exhibit A** and made a part hereof by this reference.

**NOW, THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:

<u>SECTION ONE</u>: An Agreement to Amend the Conditions of Approval to a Final Plat of Subdivision attached hereto in **Exhibit A**, be and it is hereby approved and the Village President and Village Clerk are hereby directed to execute said Agreement.

# AGREEMENT TO AMEND A CONDITION OF APPROVAL TO A FINAL PLAT OF SUBDIVISION

WHEREAS, the Village of Sugar Grove is not a home rule municipality within Article VII, Section 6A of the Constitution of the State of Illinois, and, accordingly acts pursuant to the powers granted to it under 65 ILCS 5/1-8 et. seq. and other applicable laws; and,

WHEREAS, Kyle and Stephanie Kimmie are the subdividers and legal owners of a certain Property, as hereinafter defined; and,

**WHEREAS**, a Final Plat of Subdivision of Kimme Subdivision was recorded on June 15, 2021 with the Office of the Kane County Recorder as Document No.2021K045614 ("Property"); and,

**WHEREAS,** the Property is commonly identified by PIN 14-03-300-028 and legally described as: Part of Section 3, Township 38 North, Range 7, East of the Third Principal Meridian, in the Township of Sugar Grove, the County of Kane, State of Illinois; and,

**WHEREAS,** as a condition of said Final Plat of Subdivision of Kimme Subdivision, pursuant to Section 1.G of Resolution No. 2020-1215C, the corporate authorities of the Village of Sugar Grove required that the subdivider pay a fee in lieu of the sidewalk construction along the Denny Road frontage; and,

WHEREAS, the Parties now wish to amend said condition.

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

## Exhibit A

- 1. The condition of approval for the Final Plat of Subdivision set forth in Section 1.G shall hereby be amended as follows:
  - G. That the subdivider shall pay a fee in-lieu-of construction of the required sidewalk along Denny Road if the Village Board approves a subdivision of the property adjoining on the west on or before September 6, 2024.
