ISSUE

Should the Board adopt a resolution Amending Fees and the Number of Licenses per Liquor Class for Fiscal Year 2022-2023.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, from time to time the Village Board may set fees and the number of licenses for each liquor class. Burnt Barrel Social has submitted an application for a Class E - Restaurant liquor license. Staff has reviewed the new liquor license application and is working with the applicants to complete all required paperwork. To minimize any delay in issuing the liquor license, staff recommends that the Village Board approve the license subject to staff review. Setting the number and fee for the licenses now will allow staff to work with the applicant to complete the applications and issue a liquor license in a timely manner. The fee for the Class E - Restaurant Liquor license for a full year is \$1,850.00. The license fee for Burnt Barrel Social has been prorated to \$770.80 for December 1, 2022 through April 30, 2023.

WHEREAS, Village Code Chapter 2, Section 3-2-7: Number of Licenses, provides that the cost and fees for obtaining and maintaining liquor licenses within the Village of Sugar Grove shall be set from time to time by the Board of Trustees of the Village of Sugar Grove by resolution of said Board of Trustees; and;

WHEREAS, Village Code Chapter 2, Section 3-2-7: Number of Licenses provides that maximum number of allowable per Class Licenses shall be determined by resolution by the Board of Trustees. In addition, the Board of Trustees may regulate the number of licenses by geographical area within the Village of Sugar Grove;
