**ISSUE**

Should the Village Board approve the purchase of Body Worn Cameras, Professional Redaction Software and peripheral equipment with Axon Enterprises, Inc.

**DISCUSSION**

The Sugar Grove Police Department has been researching body worn camera equipment and redaction software in preparation to fulfill an unfunded State mandate, passed under the Safe-T-Act. Municipal police departments of our size, must outfit each officer with a body worn cameras by January 1, 2025 per the new law, 50 ILCS 706- Law Enforcement Officer-Worn Body Camera Act.

Staff is fully supportive of implementing a body worn camera program. There are many benefits in moving forward with a body worn camera program in advance of the time-frame established by the State. Communities expect their departments to be transparent and have the ability to keep current with best practices. Many agencies have already implemented body worn camera programs

As a reminder in April, 2022, the Village of Sugar Grove received a grant from the Small Rural Tribal Body Worn Camera Program in the amount of \$22,000. The Village needs to match the grant with their own funds of \$22,000. Funds need to be expended from January 1, 2022 through December 31, 2024. This is a 50/50 grant program totaling \$44,000.

Based on the research received and reviewed, Sugar Grove Police Department's desire is to utilize the same vendor for both the in-car camera system and body worn cameras. The advantage in doing this, has tremendous value for presenting a case from high profile, to as simple of a traffic enforcement encounter being all synched together, side by side.

The Sugar Grove Police Department began moving in-car cameras to the Axon Fleet system with the purchase of the four cars last budget year and with three additional cars budgeted this year. Seven of our squad cars will have the Axon Fleet in-car camera system in place. The cost for the cloud storage of the unlimited videos captured on the in-car cameras through Axon is free. As our remaining squad cars are being changed out each budget year, the intent is to convert the old in-car camera system over to the new platform, Axon Fleet.

Officers have tested the Axon Body Worn Cameras along with the integration of the Axon in-car camera system and have seen tremendous advantage of the two products in-concert on the same platform synced together. In addition, all body worn camera videos are stored in their secured cloud-based software system. Storage on the cloud vs. us storing it locally has reduced hands on staff time as multiple requests from the prosecutors and the court system are expedited with sharing of the videos via a secured link. (Staff currently spends ten plus hours a week uploading and burning DVDs and transporting them to the respective court facilities. Also at the same time, responding to FOIAs and civil proceedings for the videos, etc.) Axon offers a professional redaction software product that will save our staff time on blurring out faces and/or license plates throughout the entire video, i.e., a 30 second video up to hours long. The professional software version will save staff time over utilizing a basic redaction software.

North Aurora Police Department and Aurora Police Department currently have Axon Body Worn Cameras. If a Sugar Grove officer is on the scene with another agency with the same body worn camera system, the videos can be shared and linked to the home agencies case.

Staff was able to leverage the pricing from North Aurora's purchase from Axon, that went through an RFP process with body worn camera vendors requested by North Aurora. In addition, we received a total of three quotes, with one of them from Axon.

Vendor 1- Axon (5-year plan)      \$104,934.56

Vendor 2 (5-year plan) \$79,708.00

Comes with a standalone computer workstation for redaction as it requires voluminous time to manually redact the videos. Storage plan costs quoted would need to be evaluated as they had a commented about a one-year retention desire for most videos. Our desire is to store videos longer as the statute of limitation on certain claims will be longer than a year. Plus, their storage costs on the quote would need to be re-evaluated based on storing videos longer. In addition, they are still working on a professional redaction software system as the vendor mentioned that it should be available in the next six to nine months. Sugar Grove would also need to purchase their in-car camera system to integrate the two platforms and staff time to redact is of concern.

Vendor 3 (5-year plan) \$99,093.00

Sugar Grove would also need to purchase their in-car camera system to integrate the two platforms. Back-end user software evaluation was manageable

but not as efficient as Axon and would require more staff interaction/time for court, FOIAs and attorney requests, etc.

Staff recommends that we purchase body worn cameras, peripheral equipment, and the professional redaction software from Axon. The length of the agreement is for five years. (December 2022 through December 2027)

## **COST**

Sugar Grove Police Department budgeted in FY22-23, \$39,043 for the body worn camera system and an additional \$12,900 for redaction software, totaling \$51,943. As a reminder, the Village received a grant of \$22,000 for this initiative.

Year one of the agreement (FY22-23 budgeted) would be \$51,943. Years two through five would be \$13,247.89 each respective year. The cloud storage costs for body worn cameras are subject to change only if we need to increase the amount of cloud storage over the years. Storage costs have come down considerable and the amount of adding multiple terabytes is currently under \$1,000.

The total five-year cost is quoted at \$104,934.56
