### ISSUE

Should the Village Board approve services through Everbridge/Nixle for providing our community with an Emergency Management Notification System.

## DISCUSSION

The Village Board discussed funding options regarding Nixle as an Emergency Notification platform for the community at the last board meeting on November 15. As a reminder, the Sugar Grove Fire Protection District desired to opt out of partnering with the village on this endeavor. The billing cycle through Everbridge/Nixle is November of each year. Over the past two years, the Village paid 50% with the Fire Protection District paying the other 50% of the costs. Now that the FD has opted out, the Village of Sugar Grove, will need to cover 100% of the overall annual cost of \$5,800.

The Board at the last meeting by consensus agreed to continue with the program and to split the additional unbudgeted funding (\$2,900) equally between the General Fund and Water Fund.

### COST

PD General Fund will now pay this fiscal year \$2,900 and PW Water Fund will also now pay \$2,900 for a total cost of \$5,800. (Current FY budget reflects \$1,450 in the PD General Fund and \$1,450 in the PW Water Fund)

**RECOMMENDATION –** That the Village Board approve the purchase of services through Everbridge/Nixle for providing a platform to push out community notification for Emergency Management Notifications and Community Alerts and approve Resolution #2022-1206PD in the amount of \$5800.00.
