SUBJECT: ORDINANCES ABATING 2022 TAXES RELATED TO DEBT SERVICE

ISSUE

Shall the Board abate the property tax levies related to the following General Obligation Alternate Revenue Bonds: 2013A Bond issued in the amount of \$5,460,000 and the 2017 Bonds issued in the amount of \$3,100,000

DISCUSSION

The designated revenue sources for these bonds, pursuant to Bond Ordinances, are net water and sewer revenues, capital improvement funds, and non-home rule sales tax. There is sufficient revenue from these sources, other than property taxes, to make the debt service payments. Should the Board not pass the proposed ordinances, the Board opens the Village up to legal action by tax objectors and limits its ability to issue new debt under the alternate bond scenario.

Attached are the ordinances abating the property tax levies for each of the above issuances.

WHEREAS, the President and Board of Trustees (the "Board") of the Village of Sugar Grove, Kane County, Illinois (the "Issuer"), by ordinance adopted on the 5th day of March, 2013, (the "Ordinance"), did provide for the issue of \$5,460,000 General Obligation Bonds (Alternate Revenue Source) (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the issuer will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying the debt service due on the Bonds during the next succeeding bond year; and

WHEREAS, it is necessary and in the best interests of the Issuer that the tax heretofore levied for the year 2022 to pay such debt service be abated:
