ISSUE

Should the Village Board approve a resolution to add an additional entrance sign at 601 Heartland Drive.

DISCUSSION

Since the newly created Economic Development Department moved into Public Works, the Village Board requested the Public Works Monument sign to be updated to include Public Works, Community Development and Economic Development. After much research and receiving quotes it was determined it was cost prohibitive to replace the current Monument sign. Staff worked with Aurora Sign Co. to design a cost-effective sign to include Community Development and Economic Development mounted next to the existing Public Works Monument sign. The cost for the additional 601 Heartland Dr. Community Development and Economic Development sign is \$5,087.44.

COST

The cost of the additional sign is \$5,087.50. The additional 601 Heartland Dr. sign was not included in FYE 23 budget; however, the funds are available in 01-54-6406 presented during the FY22-23 Mid-Year Budget update; \$12,000 was added to the projections for this item. This project was budgeted last FY but due to supply issues it was not completed.

Aurora Sign Company will return the area to a workable condition to allow the customer to do the final landscaping involved. The above contract pricing is calculated with engineered footings for soil types common to your area. Upon excavation of abnormal soil conditions, (i.e.loose compaction, fresh backfill, abnormal backfill, building debris, hidden concrete) additional cost may be incurred. These additional costs will be passed along to the customer at a rate of cost plus 15% for handling.


