ISSUE

Should the Village/Board approve the purchase of 5 (five) Fleet 3 Mobile Squad Car video systems for the Police Department.

DISCUSSION

The police department has been changing out the in-car camera system over from our old vendor, L3 Mobile Vision to Axon's Fleet 3 system. Normally from a timing perspective, this happens when a new squad car is purchased and outfitted with new equipment. Seven of the twelve video equipped squad cars will have the new Fleet 3 Axon Camera system installed from over the past two budget cycles by the end of this fiscal year.

Over the past couple of months, two older squad cars with the L3 equipment began to fail. A couple of the squad cars had the "brain box" go bad and the units ceased to function. The old vendor, no longer is selling the same product and had declared the end of life to the system a few years back. Purposefully we had old equipment-sitting in storage from decommissioned squad cars. Subsequent to the failures, we swapped older L3 units to keep the two squad cars operational. Some of these units are seven to ten years old and have been housed in the back of the squad car's rear equipment tray. As these units are part of the squad car, they are in continuous motion when in use. Staff is concerned how much long these older units will continue to function. There is also a desire to be on the same platform for the in-car camera system, but timing to wait for the remaining five squad cars to be replaced and installing new equipment isn't scheduled to occur until one to four years out in normal squad car replacement rotation.

Thus, staff is wanting to change out the remaining five squad cars in-car camera system from the L3 Mobile Vision to the Axon Fleet 3 system in advance of the normal rotation. Although staff is desiring to change over the in-car camera system earlier than anticipated, the units will be transferable to the new replacement squad cars when that occurs. Funding already exists to cover the squad in-car camera system for the five squad cars in the Capital Budget Vehicle Replacement Fund.

Staff recommends the purchase of the five Axon Fleet 3 in-car camera systems for the remaining squad cars. As a reminder, the Fleet 3 in-car camera system is integrated with the Axon Body Worn Cameras that the officers are wearing.

As a timing perspective with our vendor, Axon we currently have three Axon Fleet 3 squad car in-car camera systems are due to be shipped over the next couple of months for the three replacement squad cars ordered for this fiscal year. Two replacement squad cars should be due to be arriving this week and the third replacement squad car is scheduled to come the following month. It is our request of Axon to deliver these three in-car camera system units and push up the timeframe if the Board approves this purchase at the same time. Axon's delivery of the Fleet 3 units is running six to twelve months lead time from signing the quote to delivery, due to the supply chain issues and overwhelming demand from police agencies around the world requesting this product.

COST

The cost for purchasing five Fleet 3 in-car camera systems is \$50,000. While this is an unbudgeted expense for Fiscal Year 2022- 2023 in account 30-51-7006 (Vehicle Capital Fund), over the depreciation of the vehicle's, monies have already been set aside to cover the unexpected expenditure.

RECOMMENDATION

That the Village Board directs staff to purchase the five new Fleet 3 squad car incar camera systems and adopts the Resolution 2023-PD-0221b approving the purchase of Fleet 3 in-car camera systems with Axon Enterprise Inc.,


