ISSUE

Shall the Village Board authorize release of the public improvement guarantee being held for the construction of public improvements at the Rosewood event venue.

DISCUSSION

Julie Warpinsky, the owner and operator of Rosewood, is requesting release of the public improvement bond provided to the Village for the stormwater management facilities and other public improvements constructed on the property.

The release of the public improvement guarantee is a two-step process; first, the cost of the public improvements, second, the release of the maintenance guarantee following the eighteen month warranty period. In accordance with the Subdivision Regulations, the guarantee that was provided for the cost of the public improvements was released upon satisfactory inspection thereof and submittal of required documentation.

The second step, the warranty period, is intended to discover any flaws in material or construction. The warranty period is now completed and a subsequent inspection detected no flaws in the improvements. Village staff and the Village Engineer are of the opinion the warranty period for the public improvements has been satisfied and the entire guarantee amount can be released.

The Village Code requires Village Board approval to release the entirety of a public improvement guarantee.
