ISSUE

Should the Board adopt a resolution Amending Fees and the Number of Licenses/Permits per Liquor Class for Fiscal Year 2023-2024.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, from time to time the Village Board may set fees and the number of licenses for each liquor class. At the December 6, 2022 meeting, the Village Board approved a new Liquor License Ordinance, which streamlined liquor license classifications and created new overlay permits for Bring Your Own Beer/Beverage (BYOB) and a Food Service Waiver. While fees were not formally adopted at that time, the Board reached consensus that Annual Liquor License fees should be set at \$1,500, Temporary License fees at \$750.00, BYOB permits at \$100.00 and that there should be no fee for Food Service Waivers.

The attached resolution includes the number and fees for all current liquor license holders and requested permits.

COST

There is no cost to approve the resolution. The total revenue received from the licenses/permits is \$19,600.00.

Amending Fees and the Number of Licenses/Permits per Liquor Class for the 2023-2024 Licensing Year

BE IT RESOLVED, by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois as follows:

WHEREAS, Village Code Chapter 2, Section 3-2-8: Number of Licenses, provides that the cost and fees for obtaining and maintaining liquor licenses within the Village of Sugar Grove shall be set from time to time by the Board of Trustees of the Village of Sugar Grove by resolution of said Board of Trustees; and;

WHEREAS, Village Code Chapter 2, Section 3-2-8: Number of Licenses provides that maximum number of allowable per Class Licenses shall be determined by resolution by the Board of Trustees. In addition, the Board of Trustees may regulate the number of licenses by geographical area within the Village of Sugar Grove;

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of the Village of sugar Grove, Kane County, Illinois as follows:

That the annual fee for each class of liquor license and the number of licenses per Class within the Village of Sugar Grove shall be allocated as follows:
