ISSUE

Should the Village Board approve a resolution to purchase LED Street Light Retrofit Kits.

DISCUSSION

Staff applied for the ComEd Energy Efficiency Program Incentive to convert all the Street lights to LED within the East & West Sides of Town, Prairie Glen and Gordon Road for a total of 121 street lights. The grant covers replacing the existing 121 cobra style street light fixtures with LED light fixtures. The cost for the LED Retrofit Kits is \$38,789.44. With the estimated COMED Incentive of \$10,000.00 the cost is reduced to \$28,789.44, while the Village receives \$24,000 from the Civic Contribution, reducing the total project to \$4,789.44. In addition to the decrease in energy consumption of 65% and lighting maintenance costs, the village will see savings in longer light lifespan. The new LED lighting fixtures are estimated to last approximately 20 years versus the current village lighting fixtures, which require replacement approximately every five years. Staff received 3 proposals for 121 LED Street Light Retrofit Kits from local suppliers that conform to the COMED Program.

The LED Street Light Retrofit Kits would be installed in house by Public Works staff.

COST

The cost to purchase the 121-replacement LED light fixtures is \$38,789.44. The estimated ComEd Energy Efficiency Incentive would be \$10,000.00 and \$24,000 from the Green Energy Civic Contribution through our Municipal Aggregation Program coordinated by the Finance Department. The funds are in the Streets General Fund Budget Account number 01-53-6610: Traffic Control Supplies, which has \$45,750.00 budgeted to purchase replacement led light fixtures.

RECOMMENDATION

The Village Board approve a resolution #20230516PW1 to purchase 121 LED Street Light Retrofit Kits in the amount of \$38,789.44. The final cost for the replacement LED Street Light Retrofit Kits with the estimated ComEd Incentive of \$10,00.00 and Green Energy Civic Contribution of \$24,000 is \$4,789.44. The Streets General Fund Budget Account number 01-53-6610: Traffic Control Supplies has \$45,750.00 budgeted to purchase a replacement LED Street Light Retrofit Kits, as we have to purchase all the lights and receive the offsetting revenue.
