ISSUE

Shall the Village authorize the execution of an agreement with Kathleen Field Orr for legal services.

DISCUSSION

During the creation of a TIF, the process requires a significant amount of legal requirements and statutory requirements. To make sure the process follows the legal requirements, an attorney who specializes in TIF's is brought on to manage this process. The Village has worked with Kathleen Field Orr in the past. Kathleen Field Orr is a highly respected attorney not only in the TIF realm, but in Municipal Law.

COST

The cost for legal services is \$225/hour and will be paid by the developer, Sugar Grove LLC.
