**ISSUE**

Should the Village Board approve the purchase of a replacement Chevy Silverado 3500HD 4x4.

**DISCUSSION**

The FYE 24 budget included funds to purchase a Chevy Silverado 3500HD 4x4 with snow plow to replace the current 2007 F-350 4x4 with snow plow. Staff was able to locate a 2024 Silverado 3500HD 4x4 that was not pre-sold and would be available for us to purchase using the GM Bid Assist Program. Staff Recommends the Village waive the bidding process and purchase the Chevy Silverado 3500HD 4x4 with snow plow and utility cap from Vaessen Brothers Chevrolet.

Vaessen Brothers offered a fair trade in amount of \$9,000 on current truck, staff recommends declaring the 2007 F-350 surplus and trading it in to Vaessen Brothers Chevrolet.

**COST**

The cost of the Replacement Chevy Silverado 3500HD 4x4 is \$83,104.00. The purchase will be made from the Streets Capital Projects Fund, account number 30-53-7006: Vehicles which included \$87,925.00 for this replacement.

**RECOMMENDATION**

That the Village Board approve **Resolution # 20230620PW2** authorizing the purchase of a 2024 Chevy Silverado 3500HD 4x4 in the not to exceed amount of \$83,104.00 from Vaessen Brothers Chevrolet, Inc.
