ISSUE

Should the Village Board approve a sidewalk replacement program.

DISCUSSION

Over the past few years staff has focused on repairing as many trip hazards as possible on sidewalks using concrete lifting and grinding as it is the most cost-effective way to repair sidewalk trip hazards. However, there are still many sidewalks that need replacement. Staff has completed a list of sidewalks that will need to be replaced and received proposals from three local contractors to complete the replacement of approximately 2,200 square feet of sidewalk.

COST

The cost of the Sidewalk Replacement Program is \$30,150.00. The FYE 23 budget account number 01-53-6405 Repair & Maintenance Services ROW will be Amended to include the repairs.

RECOMMENDATION

The Village Board waives the bidding process and authorizes the Director of Public Works to contract with Norwood Concrete and not to exceed the amount of \$30,150.00 for the Sidewalk Replacement Program.
