ISSUE

Should the Village Board approve Dugan Woods Water Main Project change order #1.

DISCUSSION

The Dugan Woods water main project was awarded to Conley Excavating & Construction at the January 17, 2023 Regular Board Meeting. During construction staff noticed several of the existing storm sewer pipes were in desperate need of replacement. It should be noted that all the storm sewer pipes that need to be replaced are under the soon to be resurfaced road.

Conley Excavating & Construction provided a Change Order in the amount of \$43,469.00 to replace all the failing storm sewer pipes. The Project was originally \$18,204.50 under budget, the Change Order will make the Project over budget by \$25,264.50. Staff recommends approving Change Order #1 to have the storm sewer pipes replaced.

COST

The Project is included in the FYE 24 budget in account: 51-71-7008: Water Capital Budget. This change order would cause this line item to be over budget by \$25,264.50.

RECOMMENDATION

The Village Board approves **Resolution #20230905PW3** with Conley Excavating & Construction for Change Order #1 for the Dugan Woods Water Main Project.
