ISSUE

Should the Village approve the purchase of a Bobcat Rough Cut Mower.

DISCUSSION

At the December 5, 2023, Board Meeting Budget Surplus expenditures were discussed. The purchase of a Bobcat Rough-Cut Mower was requested at budget time and tabled until mid-year Budget projections. Public Works would typically rent this mower 2-3 times a year at a cost of around \$1,500 per year, not including staff time to pick-up and return. The life expectancy on a piece of equipment like this is around 10-12 years. This mower would be used to mow drainage ditches, storm water detention areas, Mallard Point open space and road ditches as needed. Staff received a quote of \$10,669.90 from Atlas Bobcat Company for the Rough-Cut Mower. Due to the specialized nature of this equipment and previous rental experience with the Bobcat Rough-Cut Mower staff recommends waiving the bidding process and purchasing the Bobcat Rough-Cut Mower from Atlas Bobcat Company.

COST

The cost to purchase the Bobcat Rough Cut Mower is \$10,669.90. The Streets General Equipment Fund Budget Account number 01-53-6500 has funds to cover this purchase.

RECOMMENDATION

That the Village Board waives the bidding process and approves **Resolution # 20231219PW1** authorizing the purchase of a Bobcat Rough-Cut Mower in the not to exceed amount of \$10,669.90 from Atlas Bobcat Company.
