ISSUE

Should the Village Board approve the police department's request to purchase a speed / message trailer from Applied Concepts, Inc. as mentioned at the Village's review of the six-month projected budgeted surplus at the December 5th meeting.

DISCUSSION

Background: The police department during fiscal year 23-24 budget process requested funds to be utilized for a speed /message trailer unit. During the internal department budget discussions, it was recommended that this item be temporarily placed on hold. It was to be brought back during the Village's six-month budget process, to see if the village was in a good fiscal position at that time.

The Village currently owns two variable message trailers that are stored at Public Works. The two units have been deployed over the past couple of years for special events, roadmaintenance projects, mowing, water boil orders, as well as being loaned out to other municipalities. Most of the past deployments of the two units have been for known planned events or projects.

The Police Department is still desiring to utilize the two variable message trailers owned by the Village. These two units still serve a great purpose for all of us in the village. If an emergency occurs and the two message units are already deployed in the field, or up at the Public Works facility, the ability to relocate it to the emergency scene or known deployment area could complicate matters. As these units may not be deployed due to manpower (24/7) or safety reasons, such as abandoning them or pulling them off a known road hazard or boil order, etc.

Thus, there is a need for the police department to have their own unit available at the police facility to rapidly deploy for both planned (day-to-day) and for emergency operations.

The request is not to add an identical trailer to the fleet, as the best use of the proposed trailer will be one with an embedded radar unit, along with the all-inclusive message board. Having this type of trailer available for deployment will assist us to educate the public as part of our safer community initiative. Speeding autos continues to be a high concern for residents throughout all subdivisions from provided feedback. This new radar trailer would become part of our education campaign throughout the village for those requesting extra assistance in their neighborhood, along with other operational deployments.

At the December 5, 2023, Village Board meeting, Finance Director Anastasi presented a report outlining the Village's six-month budget with a projected surplus of funds. Part of that discussion was the police department's request to purchase a new Public Safety Speed / Message Board (trailer). Over a year ago during the budget process when researching costs for a radar/messaging trailer, the costs were around \$15,000. New inquiries on cost twelve months later have companies quoting nearly \$18,700 for all the features desired with their units.

COST

As presented at the six-month budget review at the last meeting, the Village is projected to have a surplus at the end of the fiscal year. The cost of purchasing the speed radar / messaging board trailer (MC 360) a is \$18,650.00 from Applied Concepts, Inc. (Stalker Radar)

RECOMMENDATION

The Police Chief are hereby authorized to execute the purchase on behalf of the Village and to take such further actions as are necessary to fulfill the terms of said purchase.


