ISSUE

Shall the Village Board authorize release of the public improvement guarantee being held for the public improvements related to the public improvements associated with the Kimme Subdivision.

DISCUSSION

The subdivider is requesting release of the public improvement bond they provided the Village for specified public improvements constructed when the residence was constructed.

The release of the public improvement guarantee is a two-step process; first, the cost of the public improvements, second, the release of the maintenance guarantee following the eighteen-month warranty period. The warranty (maintenance) period is intended to discover any flaws in material or construction after completion of the improvements. No such flaws have been detected in the project since it was completed.

The guarantee for the cost of the public improvements was previously returned to the subdivider. Village staff and the Village Engineer are of the opinion the warranty period for the public improvements has been satisfied and the entire guarantee amount can be released.

The Village Code requires Village Board approval to release the entirety of a public improvement guarantee.
