**ISSUE**

Should the Village Board approve the 2024 sidewalk replacement program.

**DISCUSSION**

Over the past few years staff have been focused on repairing as many trip hazards as possible on sidewalks using concrete lifting and grinding as it is the most cost-effective way to repair sidewalk trip hazards. However, there are still many sidewalks that need replacement. Staff has completed a list of sidewalks that will need to be replaced and received proposals from 3 local contractors to complete the replacement of approximately 1,600 Square feet of sidewalk.

**COST**

The cost of the Sidewalk Replacement Program is \$25,000.00. The FYE 25 budget account number 01-53-6405 Repair & Maintenance Services ROW includes funds for this project.

**RECOMMENDATION**

The Village Board waves the bidding process and authorizes the Director of Public Works to contract with Wilson & Sons in the not to exceed amount of \$25,000.00 for the Sidewalk Replacement Program.
