ISSUE

Seeking approval from the Village Board to adopt a resolution Amending Fees and the Number of Licenses/Permits per Liquor Class for Fiscal Year 2024-2025.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, the Village Board may set fees and the number of licenses for each liquor class from time to time. Staff requests approval to add a Temporary Liquor License for current license holders at a fee of \$100, in addition to the \$750.00 fee for non-license holders.

The attached resolution includes the number and fees for all current liquor license holders, temporary licenses, and requested permits.

COST

There is no cost to approve the resolution. The total revenue received from the licenses/permits is \$19,600.00.
