ISSUE

Seeking approval from the Village Board of the liquor licenses for the 2024-2025 licensing year.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, liquor licenses are required for all establishments that sell or serve alcoholic beverages. Establishments are required to apply annually for license renewal. This year applications are being issued under the new format approved by the Board in December 2022. This includes new classifications and overly permits.

Staff has reviewed the following liquor license renewal applications and found them to be in substantial compliance with the Village Code.

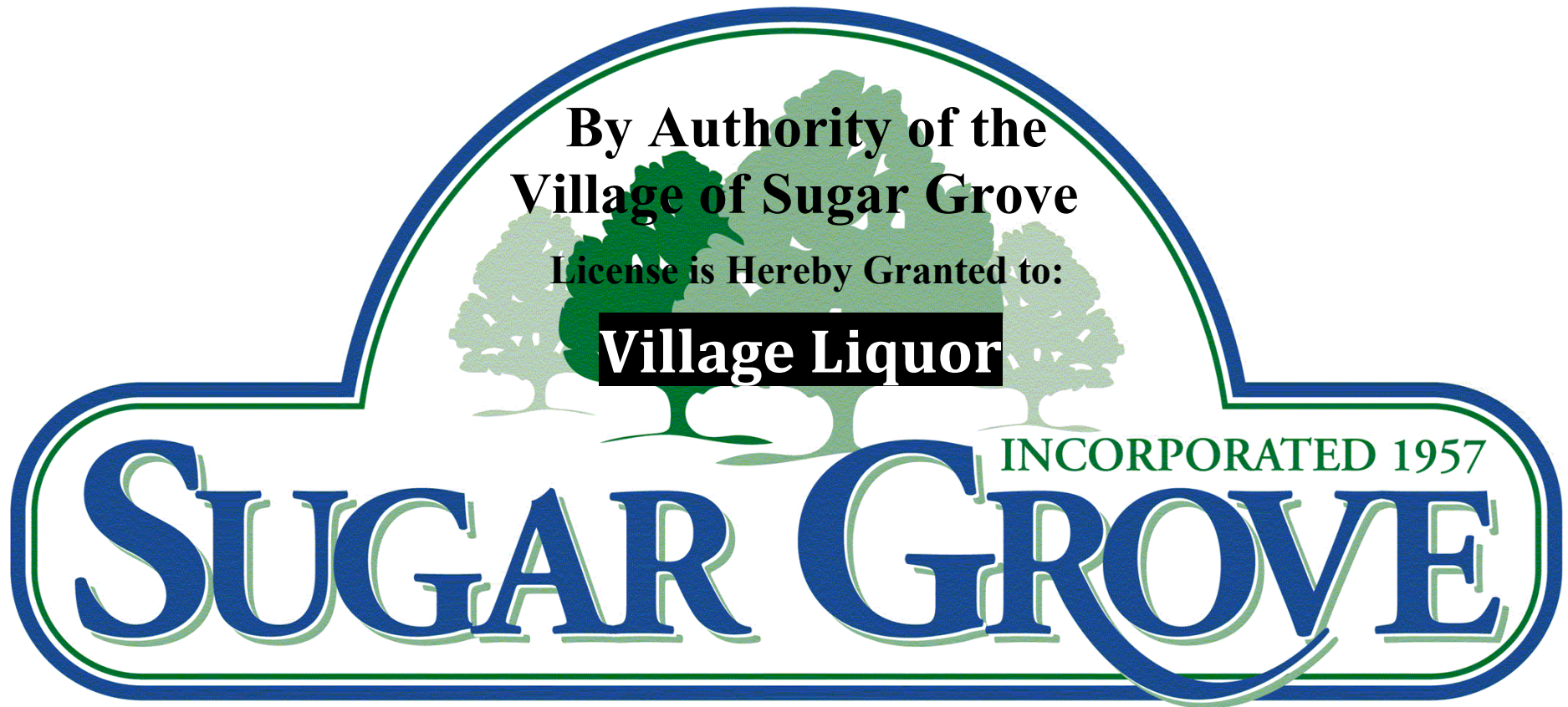
