ISSUE

Shall the Village Board Approve the Sugar Grove Center Special Service Area Assessment tax levy.

DISCUSSION

The Sugar Grove Center Special Service Assessment tax levy is for the maintenance, repair and replacement of storm water detention basins as well as to authorize the implementation and continuation of a Mosquito Abatement program. There has not been a Tax Levy on the Special Service Area #10 since Tax Year 2016, collected in 2017. The Assessment approved allows for a levy of up to \$0.50 per \$100 of EAV but can be lower. Based on the previous years expenses to maintain the area, the Village spends roughly \$10,000-\$12,500 annually. It was determined to levy \$0.20 per \$100 of EAV for Tax Year 2024, collected in 2025. This is estimated to collect roughly \$14,650 in collections.

Please find attached an ordinance allowing the Village to collect the special assessment and the levy ordinance.

ORDINANCE NO. 20241203SSA#10

An Ordinance levying taxes for the Sugar Grove Center Special Service Area Assessment for the VILLAGE OF SUGAR GROVE, KANE COUNTY, ILLINOIS, for the fiscal year commencing on May 1, 2025, and ending April 30, 2026.

BE IT ORDAINED by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois:

SECTION ONE: That the amounts herein after set forth or so much thereof as may be authorized by law, and the same is hereby levied for the Sugar Grove Center Special Service Area Assessment, for the fiscal year of the said Village of Sugar Grove, Kane County, Illinois, beginning May 1, 2025, and ending April 30, 2026.

SECTION TWO: The amount hereby levied for the Sugar Grove Center Special Service Area Assessment is one half percent (.2% or \$.20 per \$100) of the equalized assessed valuation.

SECTION THREE: That the Village Clerk shall make and file with the County Clerk of said County of Kane, a duly certified copy of this Ordinance and that the amount levied by Section Two of the Ordinance is required by said Village of Sugar Grove as aforesaid and extended upon the appropriation tax book for the fiscal year of said Village of Sugar Grove beginning May 1, 2025, and ending April 30, 2026.

SECTION FOUR: If any section, subdivision, sentence, or clause of the Ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance.

SECTION FIVE: This Ordinance shall be in full force and effect from and after its passage, approval and recording according to law.
