ISSUE

Seeking approval of a resolution amending the number of liquor licenses per liquor class for Fiscal Year 2024-2025.

DISCUSSION

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, from time to time, the Village Board may set the number of licenses for each liquor class. The Sugar Grove American Legion has applied for a temporary liquor license for the Corn Boil Event taking place July 25 – 28, 2024 in Volunteer Park, 61 S Main Street, Sugar Grove. The fee for a temporary license issued to an annual liquor license holder is \$100.
