ISSUE

Seeking approval of a resolution amending the number of liquor licenses per liquor class for Fiscal Year 2024-2025.

DISCUSSION

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, from time to time, the Village Board may set the number of licenses for each liquor class. Primos Tacos Inc. has submitted an application for an On-premise Liquor License and is seeking approval from the Village Board. Village staff has reviewed the application, and all the paperwork is in order. To minimize the delay in issuing the liquor license, staff recommends that the Village Board approve amending the number of licenses per liquor class. The fee for an On-premise Liquor License for the entire year is \$1500.00. The license fee for Primos Taco's has been prorated to \$1375.00 to cover June 2024 through April 30, 2025.
