**ISSUE**

Should the Village Board approve the Fire Hydrant Repainting Project.

**DISCUSSION**

The FYE-25 Budget included \$25,000.00 for the Fire Hydrant Repainting Project. Public Works staff will test each hydrant for proper operation and perform routine maintenance on the hydrants scheduled for painting this year. The repainting project is tentatively scheduled to begin by late summer and take 3 weeks to complete.

Staff requested proposals from two local contractors that specialize in Fire Hydrant Repainting.

Contractor	Price per Hydrant
Cryder Enterprises, Inc.	\$85.00
Giant Inc.	No Quote Received Back

Staff recommend waiving the bidding process and contract with Cryder Enterprises Inc. since Cryder Enterprises, Inc completed the Fire Hydrant Painting Project for the last 13 years with excellent results.

**COST**

The cost to repaint 290 Fire Hydrants would be \$24,650. \$25,000.00 has been included for this project in the Utilities Fund – Water Operations FYE25 budget, account number 50-60-6309: Other Professional Services.

## **RECOMMENDATION**

That the Village Board waive the bidding process and approve Resolution **#20240604PW1** authorizing the Director of Public Works to execute a contract with Cryder Enterprises, Inc. to repaint 290 Fire Hydrants in the not-to-exceed amount of \$24,650.
