ISSUE

Should the Village Board approve a resolution for the purchase and installation of 1 Lift Station Wet Well Wizard Grease Fighter.

DISCUSSION

Staff is consistently having to clean several of the Village owned lift station wet wells due to an increased amount of Grease build up within the wet well. Cleaning of each wet well can take 3 staff members 4-5 hours not including a trip to Fox Metro to dispose of the waste product. The biggest battle is during the winter months when we can only expose the Vactor truck to cold temperatures for a short amount of time before it freezes up. Last year we purchased and installed 3 Wet Well Wizards and they proved to be very effective. Staff are requesting 1 additional Wet Well Wizard. USA Blue Book agreed to honor the same price as last year of \$8,878.22 which includes freight. The installation will also require Correct Electric to install a new circuit at the lift station at an estimated cost of \$4,000. The total estimated cost for purchase & installation is \$12,878.22.

COST

The cost of the Purchase and Installation of 1 Wet Well Wizard is \$12,878.22. FYE 25 Account number 50-65-6403 Sewer System Repair & Maintenance has \$15,000 included for the Purchase and Installation of 1 Wet Well Wizard.

RECOMMENDATION

The Village Board approves <u>Resolution # 20240521PW4</u> authorizing the purchase of 1 Wet Well Wizards from USA Blue Book in the not to exceed amount of \$8,878.22. and time and material electrical installation with Correct Electric in the not to exceed amount of \$4,000.
