### ISSUE

Should the Village Board approve the police department's request to purchase rechargeable LED sequential safety flares and accessories from Pi-Variables, Incorporated.

### DISCUSSION

On February 6, 2024, during the Village Board Meeting, a discussion agenda item took place regarding the police department's request to purchase LED sequential safety flares for outfitting the remainder of the squad car fleet. During the discussion, a demonstration of the LED sequential safety flares occurred.

The police department presented three options for the Village Board to consider. It was temporarily put on hold until the Board heard the presentation regarding the FY24-25 budget review agenda item a short time later that also covered the FY23-24 potential surplus.

The Board, after the budget discussion item revisited the police department's request to purchase the LED sequential safety flares. The Board directed staff to proceed with option #1,

1. Utilize existing surplus funds from this fiscal year's (23-24) anticipated budget and authorize the purchase.



## **COST**

As presented at the six-month budget review and preparation for FY 24-25 discussions, the Village is projected to have a surplus at the end of this fiscal year. The cost of purchasing the LED Safety Flares and accessories is \$6,325.00 from Pi-Variables, Inc. 01-51-6603.

## **RECOMMENDATION**

The Village Board approves **Resolution # 2024-00305-PD1** for the rechargeable LED Safety Flares and accessories in the amount of \$6,325.00 from Pi Variables, Inc.
