ISSUE

Should the Village Board approve a resolution authorizing an agreement with Correct Electric Inc.

DISCUSSION

Staff identified the need for 2 additional card access locations to increase security measures and minimize unwanted entrance into the office area at Public Works. Staff received a proposal for \$7,485.00 from Correct Electric Inc., the contractor that completed the original card access. This is an unbudgeted item; however, staff feel it is warranted to maintain safety within the office space.

COST

The cost of the 2 card access locations is \$7,485.00, account #01-54-6406 Building Maintenance has funds to cover the card access installation.

RECOMMENDATION
