DISCUSSION

The fiscal year FYE 2025 included funds for hydraulic wheel loader forks. Staff has requested the hydraulic forks because the manual forks are extremely difficult to adjust and to prevent accidents or injuries. I have received to quotes that include shipping for the hydraulic wheel loader forks.

COST
