WHEREAS, the Village of Sugar Grove Police Department will undergo a renovation beginning in August 2025, resulting in the loss of the Village's regular meeting space; and

WHEREAS, the Village has partnered with the Sugar Grove Public Library and the Sugar Grove Fire Protection District to secure alternate accessible locations for these meetings; and

WHEREAS, the revised 2025 Meeting Schedule continues to meet the requirements of the Open Meetings Act, providing ample notice and accessibility for the public.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:
