ISSUE

Shall the Village Board authorize Scott Koeppel or his designee to sign loan documents.

DISCUSSION

As a requirement by the IEPA for a pre-requisite to apply for a loan from the Public Water Supply Loan Program, the Village Board must authorize a representative to sign loan application documents on behalf of the Village.

The Village contracted Engineering Enterprise, Inc. to work on the Project Plan to submit to the IEPA for a low-interest loan to complete the Maple St. & Joy Court Watermain Improvements and Railroad St. Water Tank rehabilitation. These projects total over \$4 million, to go along with the estimated \$3 million utilities relocation for the widening of IL-47. It was determined after a discussion with IEPA, the best option to apply for is Maple/Joy and Water Tank projects, rather than the widening project.

The attached resolution is authorizing Scott Koeppel or his designee to sign the loan application documents for the above referenced projects.
