### **ISSUE**

Should the Village Board amend the Motor Vehicle and Traffic Code, Title 6, Chapter 3, Section 3-1-N-2-A, to restore the Main St. "No Parking Zone" from Cross St. to Meadows Drive and add subsection "B" to permit temporary parking on Main St. from Meadows Drive north to the deadend with parking restrictions based on day and hour restrictions, as well as add subsection "C" designating a tow zone on Main St. between Meadows Drive and the dead-end.

## **DISCUSSION**

The Village Board provided guidance to staff at their November 18, 2025, meeting, during which they listened to comments from the business owner at 6 S. Main St., who requested relief from parking restrictions that blocked parking from Meadows Dr to the dead-end on Main St.

The Board instructed staff to amend the Village Code to permit temporary parking on Main St. from 7 AM to 5 PM, Monday through Friday, on both sides of the street, with vehicles facing the correct direction. Additionally, after the temporary hours end, the area will be designated as a "Tow Zone" (from 5:01 PM to 6:59 AM, Monday through Friday; all day Saturday and Sunday), during which parking will not be allowed, and this area will be marked as a "Tow Zone" during those parameters.

## 2. Main Street:

a. Upon both sides of Main Street, between Cross Street and North of Meadows Drive to the dead-end in the Village, no person shall stop, park, or leave standing any

vehicle, whether attended or unattended, upon the roadway at any time, but in every event a clear and unobstructed width of the street shall be left for the free passage of other vehicles and a clear view of such stopped vehicle shall be available the entire distance of both sides of Main Street between Cross Street and north of Meadows Drive. Street to the dead end.

## b. (new)

On both sides of Main Street, from north of Meadows Drive to the dead-end in the Village, temporary parking will be allowed Monday through Friday only, 7 AM to 5 PM.

## c. (new)

Designated Tow Zone - Main Street, from north of Meadows Drive to the dead-end in the Village, enforceable Monday through Friday from 5:01 PM to 6:59 AM and all hours on Saturday and Sunday. No person shall stop, park, or leave standing any vehicle, whether attended or unattended, upon the roadway at any time (Vehicles parked in this zone during these restrictions are subject to being towed).

## **COST**

Approximately \$600 in signage plus attorney costs, as subject to attorney review- STAR.

## AN ORDINANCE AMENDING THE VILLAGE CODE OF ORDINANCES TITLE 6, CHAPTER 3, SECTION 6-3-1-N-2-A AND ADDING SECTIONS 6-3-1-N-2-B AND 6-3-1-N-2-C

**WHEREAS,** the Village of Sugar Grove is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5/1-1 et seq., and

**WHEREAS,** the Village wishes to amend Section 6-3-1-N-2-A of the Village of Sugar Grove Code of Ordinances that prohibits parking on Main St. in the No Parking Zone and,

**WHEREAS**, the Village wishes to add Section 6-3-1-N-2-B to the Village of Sugar Grove Code of Ordinances to provide for temporary parking on Main St, from Meadows Dr. to the dead-end, with designated days and hours during which it is permitted. And,

**WHEREAS**, the Village wishes to add Section 6-3-1-N-2-C to the Village of Sugar Grove Code of Ordinances to provide for a tow zone on Main St, from Meadows Dr. to the dead-end, with designated days and hours during which parking is not permitted. And

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF SUGAR GROVE, KANE COUNTY, ILLINOIS, AS FOLLOWS:

## **SECTION ONE:**

1. 6-3-1-2-A (Current Language to be removed)

Upon both sides of Main Street, between Cross Street and North of Meadows Drive to the dead-end in the Village, no person shall stop, park, or leave standing any vehicle, whether attended or unattended, upon the roadway at any time, but in every event a clear and unobstructed width of the street shall be left for the free passage of other vehicles and a clear view of such stopped vehicle shall be available the entire distance of both sides of Main Street between Cross Street and north of Meadows Drive. ## 2. Amends, 6-3-1-2-A (New Replacement Language)

Upon both sides of Main Street, between Cross Street and Meadows Drive in the Village, no person shall stop, park, or leave standing any vehicle, whether attended or unattended, upon the roadway at any time, but in every event a clear and unobstructed width of the street shall be left for the free passage of other vehicles and a clear view of such stopped vehicle shall be available the entire distance of both sides of Main Street between Cross Street Meadows Drive.

## 3. Creates, 6-3-1-2-B (New Language)

On both sides of Main Street, from north of Meadows Drive to the dead-end in the Village, temporary parking will be allowed Monday through Friday, 7 AM to 5 PM.

## 4. Creates, 6-3-1-2-C (New Language)

Designated Tow Zone - Main Street, from north of Meadows Drive to the dead-end in the Village, enforceable Monday through Friday from 5:01 PM to 6:59 AM, and all hours on Saturday and Sunday. No person shall stop, park, or leave any vehicle standing, whether attended or unattended, on the roadway at any time (vehicles parked in this zone during these restrictions are subject to being towed).

### SECTION TWO: GENERAL PROVISIONS

- 1. <u>REPEALER</u>: All ordinances or portions thereof in conflict with this ordinance are hereby repealed.
- 2. <u>SERVERABILITY</u>: Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and effect, as if the invalid provision had not been part of this Ordinance.

## **SECTION THREE:**

1. That after adoption and approval hereof, this Ordinance shall be in full force and effect in the manner provided by law.
