ISSUE

Seeking approval of a resolution amending the number of liquor licenses per liquor class for the Fiscal Year 2024-2025.

DISCUSSION

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, the Village Board may set the number of licenses for each liquor class from time to time.

Pending the approval of the on-premises liquor license for HP 1 Enterprises LLC dba Cilantro Taco Grill, the attached resolution proposes adding another liquor license to the Village's existing total. Staff recommends that the Village Board approve the amendment to increase the number of licenses for an on-premises liquor license.
