### ISSUE

Should the Village of Sugar Grove Liquor Commissioner and Commission approve an on-premises liquor license for HP 1 Enterprises LLC dba Cilantro Taco Grill, to be located at 519 Sugar Grove Parkway, Unit F, Sugar Grove, for the remainder of the 2024-2025 and 2025-2026 licensing periods?

### DISCUSSION

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, liquor licenses are required for all establishments that sell or serve alcoholic beverages. HP 1 Enterprises LLC dba Cilantro Taco Grill has applied for an on-premises all-ages liquor license and is seeking approval from the Village Board. Staff have reviewed their application and recommend approval.
