ISSUE

Should the Village Board approve the purchase of two 2025 Police Chevrolet Tahoe Vehicles for the department.

DISCUSSION

Following the rotation of our police vehicles, the Fiscal Year 2025-2026 Budget included funds to replace two Police Vehicles.

Miles Chevrolet, which holds the government contract through Chevrolet manufacturing, emailed existing government agencies on May 13th that they have additional new 2025 Police Chevy Tahoe's available on their lot. In addition, they informed us that they will have more squads coming off the production line soon and coming into their possession. They are not yet dedicated to any agency and are first-come, first-served.

Squad purchases over the past few years have been delayed/backordered for several reasons. Taking advantage of new squads earlier in the budget year will bring the department on track with the existing replacement schedule, as two squads will be replaced this fiscal year. The new squads will be rotated for the detective squad and the new deputy chief squad.

If approved by the Village Board, we have a temporary hold on two squads on our behalf.

Squad Vehicles due to be replaced this budget year are:
2019 Chevy Tahoe
2017 Ford Police Utility/Explorer

Staff recommends purchasing two 2025 Chevy Tahoe vehicles available through Miles Chevrolet, the awarded police contract holder. Once the squads are delivered to us, it will still take three to four months to be outfitted with all the equipment before being placed into service.

COST

The cost for the 2025 Chevy Tahoe Vehicles is \$58,551 per vehicle. An additional \$23,008 per vehicle is currently budgeted to provide emergency lighting, cage, storage compartments, laptop, radar, radios, squad video package, installation, and other miscellaneous equipment. The total per vehicle budget is \$81,559. The Fiscal Year 2025-2026 Capital Projects Fund, account 30-51-7006: Automotive Equipment includes \$163,118.00 for replacing two Police Vehicles.

RECOMMENDATION

That the Village Board approve the purchase of the two 2025 Police Chevy Tahoe Vehicles and associated costs to outfit them, and that the Village Board waive the bidding process and approve Resolution # 2025-0520PD authorizing the purchase of two 2025 Chevy Tahoe vehicles utilizing the Miles Chevrolet.
