#### **ISSUE**

Seeking approval of a resolution amending the number of liquor licenses per liquor class for Fiscal Year 2024-2025.

#### **DISCUSSION**

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, the Village Board may set the number of licenses for each liquor class from time to time.

Pending the approval of the on-premise liquor license for Rte. 47 Wings and Tavern, the attached resolution proposes adding another liquor license to the Village's existing total. Staff recommends that the Village Board approve the amendment to increase the number of licenses for an on-premise liquor license.

The annual fee for an on-premise liquor license is \$1,500. However, the license fee for Rte. 47 Wings and Tavern has been prorated to \$250 to cover the period from March 4, 2025, through April 30, 2025.

#### **COST**

**BE IT RESOLVED** by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:

**WHEREAS**, Village Code Chapter 2, Section 3-2-8: Number of Licenses provides that a maximum number of allowable per Class Licenses shall be determined by resolution by the Board of Trustees. In addition, the Board of Trustees may regulate the number of licenses by geographical area within the Village of Sugar Grove.
