ISSUE

The Illinois Municipal Code states in Article 8, Division 2, Section 9.9, “The corporate authorities shall make the tentative annual budget conveniently available to public inspection for at least ten days prior to the passage of the annual budget, by publication in the journal of the proceedings of the corporate authorities or in such other form as the corporate authorities may prescribe. Not less than one week after the publication of the tentative annual budget, and prior to final action on the budget, the corporate authorities shall hold at least one public hearing on the tentative annual budget, after which hearing or hearings, the tentative budget may be further revised and passed without any further inspection, notice, or hearing. Notice of this hearing shall be given by publication in a newspaper having a general circulation in the municipality at least one week prior to the time of the hearing.”

DISCUSSION

The Village of Sugar Grove will hold a public hearing for the proposed FY2026-2027 budget , at 6:00 pm at the Sugar Grove Library, located at 125 Municipal Drive, Sugar Grove, Illinois, immediately preceding the Village Board Meeting on April 7, 2026. A copy of the draft Budget will be available for public inspection at Village Hall, 160 S Municipal Drive, Suite 110, on this date.

A Notice of Public Hearing was published in the Kane County Chronicle on March 26, 2026.

The Village will spend \$53.58 on publishing the public hearing notice, account 01-56-6503 & 50-50-6503, Publishing.
