ISSUE

Seeking approval of a resolution amending the number of temporary liquor licenses in the Village of Sugar Grove.

DISCUSSION

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, the Village Board may set the number of licenses for each liquor class from time to time.

The Sugar Grove Corn Boil has applied for a temporary liquor license for the Corn Boil Event, which will take place July 23 – 26, 2026, in Volunteer Park, 61 S Main Street, Sugar Grove. The temporary liquor license will cover the dates noted above. The fee for a temporary liquor license issued to an entity that does not hold a liquor license in the Village of Sugar Grove is \$750.00.
