ISSUE

Seeking approval from the Village Board of an On-Premise, All-Ages, Temporary Liquor License (non-liquor license holder) for Sugar Grove Corn Boil NFP, for the Corn Boil event in Volunteer Park, July 23 – 26, 2026.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, liquor licenses are required for all establishments or businesses that sell or serve alcoholic beverages. Establishments are required to apply annually for license renewal.

Each license classification can be issued as Annual or Temporary, with Temporary defined as up to thirty (30) days per license year (any portion of a day is a full day).

Staff reviewed the liquor license application for the Sugar Grove Corn Boil NFP and found it complies with the Village Code's requirements.
