## ISSUE

Should the Board approve the participation in the State of Illinois purchasing program for the 2026-2027 bulk road salt purchase.

## DISCUSSION

The State of Illinois Bureau of Strategic Sourcing & Procurement is planning to award the bid for bulk road salt in the June / July 2026 time frame. Staff is requesting Board approval to participate in this year's program.

Last year's salt price through the State's program was \$70.63 per ton for salt, the price for salt outside the State's program averaged \$75.00 to \$125.00 per ton last season. Although staff is not certain on the salt price for this season historically it has been beneficial to join the state program.

Based on history of usage, current end of season estimates for remaining salt and the usage for this current season, Staff estimates the need for approximately 2,000 tons of salt to execute the 2026-2027 snow and ice control program.

## COST

The estimated cost for 2,000 tons of salt at \$90.00 per ton is \$180,000.00. The funds have been included in account number 35-53-6615: Snow and Ice Control Supplies for the FYE 27 budget.
