ISSUE

Seeking approval of a resolution amending the number of temporary liquor licenses in the Village of Sugar Grove.

DISCUSSION

Per Title 3, Chapter 2 of the Village of Sugar Grove Municipal Code, the Village Board may set the number of licenses for each liquor class from time to time.

KMZ Restaurant Group, dba Fireside Grille, has applied for a temporary liquor license to fulfill orders placed at a wine tasting event at Rich Harvest Farms on October 10, 2026.

Representatives from the wine distributor(s) will be on site to pour wine samples. Attendees will have the opportunity to order bottles of wine, pick up and pay for them at Fireside Grille later. The fee for a temporary liquor license issued to an entity that currently holds a liquor license in the Village of Sugar Grove is \$100.00.
